## The Direct Debit Guarantee

- If there are any changes to the amount, date or frequency of your Direct Debit The Mines Advisory Group will notify you 5 working days in advance of your account being debited or as otherwise agreed. If you request The Mines Advisory Group to collect a payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your Direct Debit, by The Mines Advisory Group or your Bank or Building Society, you are entitled to a full and immediate refund of the amount paid from your Bank or Building Society - If you receive a refund you are not entitled to, you must pay it back when The Mines Advisory Group asks you to
- You can cancel a Direct Debit at any time by simply contacting your Bank or Building Society. Written confirmation may be required. **Please let us know if you do this so we can update our records.**
